Terms and Conditions for 'Early Bird Places - Save £800'

These Terms and Conditions govern the 'Early Bird Places - Save £800' offer (hereinafter 'Early Bird Places') provided by Cambridge International Academy (hereinafter 'the Academy') for the 2025 University Taster Summer School. By applying for an 'Early Bird Place' applicants agree to abide by the following terms:

1. Eligibility for Early Bird Places

- An 'Early Bird Place' is available to applicants for the University Taster Summer Schools 2025.
- To be eligible for an 'Early Bird Place', applicants must meet the deadline specified in Clause 2 below, as well as completing all application requirements as outlined on the Academy's official website [here](#).
- The application process includes, but is not limited to, submission of all required documentation, academic records, any other materials specified in the application guidelines and payment of the non-refundable registration fee prior to the 'Early Bird Places' deadline.

2. 'Early Bird Places' Application Deadline

- To qualify for an 'Early Bird Place', applicants must complete the full application process and receive confirmation of their acceptance by **31st October 2024**.
- An 'Early Bird Place' is available only once per applicant and cannot be transferred or exchanged for cash or any other benefits.

3. Payment Terms

- Applicants must pay the full summer school fee (minus the £800 'Early Bird Place' award) no later than 17:00 London time on **31st October 2024**.
- Failure to pay the full adjusted fee by the deadline will result in forfeiture of the 'Early Bird Place', and the applicant will subsequently be required to pay the full Summer School fee in order to secure their place.



4. General Terms

- The 'Early Bird Place' award cannot be combined with any other promotional offer, scholarship, or financial aid provided by the Academy or other organisation, unless explicitly authorised in writing by the Academy.
- The remaining Summer School fee must be paid in accordance with the Academy's standard payment methods and policies, as detailed on the official website.
- In the event that the applicant later withdraws from the Summer School or fails to meet any other terms and conditions after payment, the Academy's standard refund policies as detailed in the general 'Terms and Condition' will apply.

5. Right to Amend or Withdraw Offer

- Cambridge International Academy reserves the right to amend, suspend, or withdraw the 'Early Bird Places' offer at any time without prior notice. Any such amendments will not affect applicants who have already qualified for, and paid the full fee for, an 'Early Bird Place'.
